OPEN MEETING MINUTES

MEETING DATE DECEMBER 27, 2017

A quorum being present, the Open Meeting of Wednesday, December 27, 2017, is called to Order by Director Gans at 12:02 p.m.

- Check # 40555 for \$8,050.00 to Skeleton Key related to the database.
- Check # 40556 for \$17,500.00 to Skeleton Key also related to the database.

Chief Spiegel states that the checks were prepared per his recommendation and he also states that the checks do not violate any State bidding statutes or constitute installment payments.
