A quorum being present, Director Gans called the meeting to order and announced the Board of Directors meeting to be in session for the transaction of any and all business to be brought before it at this time.

# 1 PROCEEDINGS

- 7:00 P.M.
- 3 DIRECTOR GANS: Call to order the
- 4 Open Meeting of the Monarch Fire Protection
- 5 District Board of Directors.
- 6 Would you all please rise and join me
- 7 in the Pledge of Allegiance?
- 8 (Whereupon, all persons joined in reciting
- 9 the Pledge of Allegiance, after which time, the
- 10 following proceedings were had.)
- 11 DIRECTOR GANS: Approval of Agenda.
- 12 Are there any additions or other
- 13 changes to the Agenda?
- 14 DIRECTOR MILLNER: I have none.
- DIRECTOR HARRIS: I believe we have
- 16 posted a possible Closed Meeting.
- 17 DIRECTOR GANS: That is posted.
- 18 DIRECTOR HARRIS: I do have infor-
- 19 mation. It -- it's not something on which we'll be
- 20 voting, but it's information I think the Board
- 21 needs to hear, this evening, I just received a bit
- 22 earlier.
- 23 And it will be public in another
- 24 week. So.
- 25 DIRECTOR GANS: Okay. So, then,

- 1 we'll have a Closed Meeting, as a part of this
- 2 Open Meeting.

- I'm going to add, under New Business,
- 5 "Newsletter."
- And that's the only change I have.
- 7 Moving on to Citizen Comments.
- There probably aren't any comments,
- 9 since there are no citizens.
- So, we'll move on to the President's
- 11 Report.
- I like to periodically give a brief
- 13 update on what's going on at Central County.
- And, sometimes, it's nothing all that
- 15 significant, but I think it's important just to
- remind the other Directors that, that is our 911
- 17 Dispatch Agency, but, even beyond that, we're one
- of five owners of Central County 911.
- 19 And Central County dispatches the
- 20 vast majority of fire and EMS departments and
- 21 districts, in St. Louis County and, also, in other
- 22 counties, it does some work.
- So, the report is brief, this time,
- 24 as -- as it has been before.
- The turnover at Central County, in

- 1 the past year, has been what I would term
- 2 moderate.
- 3 It seems, when Central County was a
- 4 smaller agency, that no one ever left. And, of
- 5 course, that's a good thing, having the experience
- and the continuity is important and was valuable.
- 7 The agency has grown quite a bit, so
- 8 we're three times-plus the employees, that
- 9 responded in more turnover.
- 10 And there has been.
- 11 So, the agency went through its
- 12 hiring list in a very quick time. A very short
- 13 time. And the -- we're going for another hiring
- 14 list, now.
- So, it's -- it's seem -- it's seeming
- 16 that we're turning over about two dispatchers a
- 17 year. Some who were there a short time and some
- of them there a moderate amount of time.
- We haven't lost any of the real
- seasoned veterans, who were probably there through
- 21 the duration of their working career.
- The other change is a turnover in the
- 23 financial advisor to the pension.
- 24 For many years, the financial
- 25 advisory was Greq Stewart and the agency went

- 1 through a bidding process and hired, then, Larry
- 2 Gwin who has a company.
- And they're actually based out of
- 4 Utah.
- 5 With a -- an agreement that they
- 6 would appear at meetings in St. Louis, as needed.
- 7 But, that they felt that they could manage this
- 8 from Utah.
- 9 One of our other owning entities uses
- 10 them and I cannot remember which it is, and they
- 11 said it works out fine, with today's
- 12 communications, devices, they'll either hold web
- meetings and communicate by video and, of course,
- 14 y email, the -- and -- and phone.
- 15 It's no longer as important to have
- someone in town, but, if any of the employees wish
- 17 to have personal conversations, if they can't be
- accomplished by phone, then the opinion is that he
- 19 would come to town, as needed.
- That doesn't mean all the time, but,
- 21 he would -- he would respond and -- and be in
- 22 town.
- And, then, finally, the by-laws call
- 24 for quarterly meetings at Central County.
- 25 Through the years, they have moved

- 1 back and forth between quarterly meetings,
- 2 meetings every -- every other month, and we've
- 3 gotten into a rotation, now, of meeting monthly.
- 4 And we have been doing that now for
- 5 about six months. The meetings are fuller and we
- find that we're probably able to work more
- 7 efficiently with meetings every month.
- 8 So, we're pretty much in a routine of
- 9 meeting now, every month and it's -- this has
- 10 worked well.
- So, if there's no questions about
- 12 Central County, I will conclude the President's
- 13 Report and turn it over to the secretary for her
- 14 report.
- 15 DIRECTOR MILLNER: All right. Thank
- 16 you.
- 17 Let's see. I have a bid for --
- 18 DIRECTOR GANS: Wait, wait, wait.
- 19 DIRECTOR MILLNER: -- for -- hold on
- 20 a minute.
- Okay. I have a bid for LED lighting
- 22 at House One.
- DIRECTOR GANS: And --
- 24 ASSISTANT CHIEF CREWS: And so it's
- 25 (not understood) for your vote, --

- 1 DIRECTOR MILLNER: Oh.
- 2 ASSISTANT CHIEF CREWS: -- that bid
- 3 was received on time.
- 4 DIRECTOR MILLNER: Thank you.
- 5 ASSISTANT CHIEF CREWS: And, it has
- 6 been sealed, since that time.
- 7 DIRECTOR GANS: Thank you.
- DIRECTOR MILLNER: Okay. I've been
- 9 instructed I'm going to have to turn away from the
- 10 microphone.
- Okay. Okay, this bid is from -- is
- 12 it Aschinger?
- ASSISTANT CHIEF CREWS: That is
- 14 correct.
- 15 DIRECTOR MILLNER: Aschinger Elec-
- 16 tric.
- 17 A-s-c-h-I-n-q-e-r, Electric.
- This is in-service.
- Okay. And the amount of this bid,
- 20 \$37,888.00 and no cents.
- 21 DIRECTOR GANS: And is that bid for
- 22 all of House One, Engine Bay, sleeping quarters,
- 23 --
- 24 DIRECTOR MILLNER: All of the
- 25 exterior fixtures to be replaced with new LED

- 1 fixtures and bollards be retrofitted with LED and
- 2 drivers.
- 3 All of the interior fixtures to be
- 4 replaced with new LED fixtures and LED "graver"
- 5 and drivers guaranteed for 120 months from the
- 6 date of installation.
- 7 DIRECTOR GANS: Okay.
- 8 ASSISTANT CHIEF CREWS: So the
- 9 answer to your -- it is a combination of interior
- and exterior with the intent to "probably" replace
- 11 the existing lights.
- 12 DIRECTOR GANS: I will be curious how
- 13 this LED project goes.
- I just replaced the third and forth
- 15 or forth and fifth LED light bulb at -- at my
- 16 house for bulbs that are supposed to last and
- 17 quaranteed to last --
- DIRECTOR MILLNER: Hm-hm.
- 19 DIRECTOR GANS: -- for -- if not ten
- 20 years, maybe, seven years.
- 21 And, LED technology hasn't even been
- 22 around for seven years.
- The good thing is, each of the
- 24 manufactures; there were two, has immediately sent
- 25 a new bulb at no charge.

- 1 One of them asked for the bad bulb
- 2 back. They said, "We'll repair it and I'll send
- 3 you a new one."
- 4 Yeah, sure.
- But, the point of that is, is that
- 6 they're supposed to be energy efficient. And I'm
- 7 not questioning that they are, but, I'm finding
- 8 that they don't have anywhere close to the life
- 9 expectancy that they advertise.
- 10 And, as long as we have warranties,
- 11 like that, it's not our problem.
- DIRECTOR HARRIS: Well, I think,
- part of that is, they'll have a disclaimer that
- 14 would tend to how -- it's based on how many hours
- 15 per day.
- 16 And, in a fixture, like our's, where
- 17 it's no doubt running, on some of them, 24 hours
- 18 a day, if we can guarantee those for ten years,
- 19 I'm delighted.
- DIRECTOR GANS: And that's a good
- 21 point. The one I just sent back, this week, had
- a seven year 40,000 hour; and I don't know what --
- I don't one's equal to the other.
- I think 40,000 hours is probably --
- 25 now I'm getting a calculator.

- 1 The good thing was, it had only been
- a little over two years and it hadn't even been
- 3 40,000 hours since I bought it.
- So, there's been less than half,
- 5 which I quess tells me that'd be about four years.
- 6 Forty --
- 7 DIRECTOR HARRIS: Actually, that
- 8 40,000 would be a little over four years.
- 9 DIRECTOR GANS: Right. So, -- and
- 10 you -- you a raise a good point that the guaranty
- is strictly based on time passage, rather than
- 12 hours of use, that's even better.
- Now, enough. Enough, where we've
- labored this point that I'll be interested to see
- 15 how it turns out.
- So, you have a bid that's been
- 17 opened.
- 18 DIRECTOR MILLNER: Yes. And I do
- 19 the instruct, or you instruct?
- 20 DIRECTOR GANS: You instruct.
- DIRECTOR MILLNER: Okay, I
- 22 would like to now instruct you to review the bid,
- 23 --
- 24 ASSISTANT CHIEF CREWS: Okay.
- 25 DIRECTOR MILLNER: -- and then return

- 1 a recommendation to the Board of Directors.
- 2 ASSISTANT CHIEF CREWS: I will do
- 3 so.
- 4 DIRECTOR GANS: Thank you.
- 5 DIRECTOR MILLNER: You're welcome.
- Okay. Next, I have Minutes.
- 7 I would like to move for the approval
- 8 of the Open Meeting Minutes for February 7, 2018
- 9 and February  $21^{st}$ , 2018.
- 10 DIRECTOR GANS: I will second the
- 11 motion.
- 12 Any discussion?
- 13 (No response.)
- 14 DIRECTOR GANS: All in favor?
- 15 DIRECTOR MILLNER: Aye.
- DIRECTOR HARRIS: Aye.
- 17 DIRECTOR GANS: Aye.
- Motion passes three to nothing.
- 19 DIRECTOR MILLNER: I would, also,
- 20 like to move for the approval of the Closed
- 21 Meeting Minutes for February 7, 2018 and February
- 22 21<sup>st</sup>, 2018.
- 23 DIRECTOR GANS: I will second the
- 24 motion.
- 25 Any discussion?

- 1 DIRECTOR MILLNER: No.
- DIRECTOR GANS: All in favor?
- 3 DIRECTOR MILLNER: Aye.
- 4 DIRECTOR HARRIS: Aye.
- 5 DIRECTOR GANS: Aye.
- 6 Motion passes three to nothing.
- 7 DIRECTOR MILLNER: I have nothing
- 8 further.
- 9 DIRECTOR GANS: All right. Thank you.
- 10 On to the Treasurer's Report.
- 11 DIRECTOR HARRIS: We have disburse-
- ments in the amount of \$116,520.06 for the period.
- 13 We have six checks over \$5,000.00.
- 14 Check number 40873, Paychex of New
- 15 York, LLC, in the amount of \$5,342.32.
- 16 Check number 40886 to Sleep Number
- 17 Corporation, in the amount of \$9,438.72.
- That would be for 28 mattresses for
- 19 House One.
- Check number 40861 to Mediclaims in
- 21 the amount of \$9,246.49. That is the January
- 22 billing.
- Check number 40833, EKON Benefits and
- that was in the amount of \$5,810.00 and no cents.
- 25 And it's annual allocation 147

- 1 reports.
- 2 Check number 40866 to Montgomery Bank
- 3 in the amount of \$7,221.99.
- And, well, there's a -- a lengthy
- 5 list of charges for the Montgomery Bank card.
- And, last, check number 40825 to
- 7 Bound Tree Medical, LLC, in the amount of
- 8 \$8,450.15.
- 9 And that is for EMS supplies.
- 10 Are there any questions?
- 11 DIRECTOR MILLNER: I have none.
- 12 DIRECTOR GANS: Well, I did -- I did
- send my questions, as I always do, by email.
- 14 And then I did receive a response
- 15 from Michelle, with some supportive help. Some
- 16 documents.
- 17 And I -- I note that there were a
- 18 large number of questions, again, this time, I
- 19 think based on the fact that we didn't meet in the
- last week, so there were more checks than normal
- 21 and there were more questions.
- I guess, the -- all the questions
- 23 were answered.
- The one thing I pulled from this is
- 25 a effort is needed, again, to have our venders

- direct bill us, when possible.
- 2 That is, rather than charging things
- 3 on our credit card that can be billed and paid for
- 4 by check.
- I find it preferable, as we all know,
- 6 I find it preferable to use the credit card as
- 7 little as possible.
- I know it's convenient and there's
- 9 times when you can't do it any other way, but,
- 10 there were a couple of things on there that I
- 11 would hope that we can investigate and find the
- 12 companies will -- will bill us and it doesn't have
- 13 to go on the credit card.
- So, those are all my comments about
- 15 the check run.
- DIRECTOR HARRIS: And all of my
- 17 questions were answered via email.
- 18 In reviewing these disbursements,
- they appear to be reasonable and necessary in the
- 20 conduct of the District's business.
- 21 Chief Crews, were these checks
- 22 prepared per your recommendation?
- 23 ASSISTANT CHIEF CREWS: Yes, sir,
- they were.
- 25 DIRECTOR HARRIS: Do they violate

- 1 any state bidding statues or constitute
- 2 installment payments?
- 3 ASSISTANT CHIEF CREWS: Not to my
- 4 knowledge.
- 5 DIRECTOR HARRIS: I make a motion
- 6 that we accept the disbursements as prepared.
- 7 DIRECTOR GANS: I'll second the
- 8 motion.
- 9 Any further discussion?
- 10 (No response.)
- 11 DIRECTOR GANS: All in favor?
- 12 DIRECTOR MILLNER: Aye.
- DIRECTOR HARRIS: Aye.
- 14 DIRECTOR GANS: Aye.
- Motion passes three to nothing.
- 16 DIRECTOR HARRIS: Just one quick
- 17 comment.
- 18 Shortly after the Civil War started,
- 19 the USS Meramec was in dry dock in Virginia where
- 20 it was scuttled by Union troops before they
- 21 retreated.
- 22 The Confederate forces refloated the
- 23 ship with a salvage crew.
- 24 They made it the first Ironclad and
- 25 renamed it the CSS Virginia.

- 1 A short time later, in 1862, it went
- 2 up against numerous ships from the Union and,
- 3 well, it reeked havoc with those wooden ships.
- And, what is noteworthy about it,
- 5 actually, is that it was basically sealing the
- fate of wooden Navy's as the entire world would
- 7 start quickly moving into Ironclads.
- 8 They -- Union ships actually hit the
- 9 CSS Virginia nearly 100 times to little effect.
- 10 It reeked havoc among those wooden
- 11 ships, as it could, basically ignore their fire.
- In a way, they're -- the USS Monitor
- 13 met with the CSS Meramec and I believe it was a
- 14 draw, but that was actually the first battle
- 15 between Ironclad's.
- And, again, the advent of a new day
- for Navy's around the world.
- 18 And that concludes --
- 19 DIRECTOR GANS: I have a question.
- DIRECTOR HARRIS: Yes.
- 21 DIRECTOR GANS: You used the term
- 22 "scuttled," --
- 23 DIRECTOR HARRIS: Yes.
- 24 DIRECTOR HARRIS: -- to do --
- DIRECTOR HARRIS: To scuttle a ship

- 1 is to render it unuseable.
- So, they actually, while it was in
- 3 serve -- in a -- an area where it was not deep in
- 4 the ocean, because it was in for repairs, they
- 5 would have done damage to it, so it would sink, as
- 6 best they could do that.
- 7 They did not set fire to it.
- 8 Sometimes, that would be done, but,
- 9 the salvage crews were able to save it, refloat it
- and they added armor plate which made it virtually
- invulnerable to the small weapons of the day.
- 12 I mean, they -- against wooden ships,
- 13 they were highly effective, but not against the
- 14 Ironclads.
- DIRECTOR GANS: Which leads me to a
- 16 question pertaining to the Fire District.
- 17 Have we given any thought to
- 18 scuttling 2297?
- 19 (General laughter.)
- DIRECTOR GANS: I notice it was towed
- 21 in for a transmission problem. It's a reserve
- 22 ambulance.
- ASSISTANT CHIEF CREWS: Yeah.
- 24 DIRECTOR GANS: And with the number
- of 97, I figure it's at the bottom of the call-up.

- 1 ASSISTANT CHIEF CREWS: Right. That
- 2 vehicle's a specialty vehicle that we use here,
- 3 but the answer to your question is that it's going
- 4 to on the auction block, here, real soon.
- 5 DIRECTOR GANS: Okay. So, scuttling
- 6 -- "my" experience, it sounds like.
- 7 ASSISTANT CHIEF CREWS: No.
- 8 DIRECTOR GANS: All right. So you
- 9 concluded your report.
- 10 DIRECTOR HARRIS: I have.
- 11 DIRECTOR GANS: I extended it, so
- 12 let's move on to the Chief's Report.
- ASSISTANT CHIEF CREWS: I have two
- 14 items, this evening. Both are RFP's.
- 15 The first one being for the "Epoxy
- 16 Floor at House Four."
- 17 And, just to let you know the area,
- 18 it's going to be the kitchen and the dining room
- 19 and the hallways that serve the day-room side of
- 20 that facility.
- 21 We're gonna ask to go out for bid at
- 22 a 30 day bid process.
- The second one, if you want me to
- 24 lump 'em together, --
- DIRECTOR GANS: No.

- 1 ASSISTANT CHIEF CREWS: -- or do
- 2 you want to keep them two separate motions?
- 3 DIRECTOR GANS: We -- we have to do
- 4 'em one at a time.
- 5 So, I will make a motion to go out to
- 6 bid for a epoxy floor at House Four, with a 30 day
- 7 bid period.
- 8 DIRECTOR HARRIS: Second.
- 9 DIRECTOR GANS: Discussion?
- 10 DIRECTOR HARRIS: Quick question.
- 11 I believe that was in our budget?
- 12 ASSISTANT CHIEF CREWS: Yes, it was.
- DIRECTOR HARRIS: That's all my --
- ASSISTANT CHIEF CREWS: That was one
- of the capital items in 2018 budget.
- 16 DIRECTOR HARRIS: I thought it was.
- 17 ASSISTANT CHIEF CREWS: Yes.
- 18 DIRECTOR GANS: Okay. So we have a
- 19 motion. We have a second. We've had discussion.
- If there's no further discussion, I
- 21 will call for the question.
- 22 All in favor?
- DIRECTOR MILLNER: Aye.
- 24 DIRECTOR HARRIS: Aye.
- DIRECTOR GANS: Aye.

- 1 Motion passes.
- We -- we'll go out to bid.
- 3 Continue.
- 4 ASSISTANT CHIEF CREWS: And the
- 5 second item is the request for a proposal to go
- 6 out to bid for turnout gear.
- 7 Again, this is a line item in the
- 8 budget. I'm not for sure the exact number that
- 9 we're looking at now. They're -- they're re-
- 10 tallying that.
- But, it's been some time since we've
- out to bid for our (not clear) firefighting gear
- and the committee got together and put together a
- 14 set of bid specifications, so we're ready to go
- 15 out to bid.
- And, we're gonna ask for that 30 day
- 17 bid process, as well.
- 18 DIRECTOR HARRIS: Are these replace-
- ments, or will the second set, or a combination?
- 20 ASSISTANT CHIEF CREWS: It will be
- 21 a combination. A combination of both.
- 22 Some of 'em will be that new set and
- then the other one will become that second set.
- 24 DIRECTOR GANS: All right. I will
- 25 make a motion to go to bid for turnout gear, with

- 1 a bid -- with a number to be determined, and by
- the committee, with a bid period of 30 days.
- 3 DIRECTOR HARRIS: Second.
- 4 DIRECTOR GANS: Any discussion?
- 5 (No response.)
- 6 DIRECTOR GANS: All in favor?
- 7 DIRECTOR MILLNER: Aye.
- 8 DIRECTOR HARRIS: Aye.
- 9 Motion passes three to nothing.
- 10 ASSISTANT CHIEF CREWS: And that's
- 11 all I have this evening. Thank you.
- 12 DIRECTOR GANS: Thank you.
- 13 Attorney's Report.
- 14 MISTER HOFFMAN: I do not have a
- 15 report this evening.
- 16 DIRECTOR GANS: All right.
- On to New Business.
- 18 It's been about five months, I think,
- 19 since we last started producing our news letter,
- or last news letter, so I would like us to begin
- 21 the produce of producing the next news letter.
- ASSISTANT CHIEF CREWS: Okay.
- DIRECTOR GANS: Okay.
- 24 ASSISTANT CHIEF CREWS: We will do so
- 25 and I guess the Board will their -- their Board-

- 1 thing?
- DIRECTOR GANS: Yes.
- 3 ASSISTANT CHIEF CREWS: Okay.
- DIRECTOR GANS: And -- and -- and,
- 5 maybe, you'll remind us, also.
- 6 ASSISTANT CHIEF CREWS: Okay.
- 7 (Light chuckles.)
- 8 DIRECTOR GANS: Even though I'm
- 9 bringing it up, reminders are always helpful.
- 10 All right. Any other New Business?
- 11 (No response.)
- 12 DIRECTOR GANS: Hearing none, any
- 13 Unfinished Business?
- 14 (No response.)
- 15 DIRECTOR GANS: Hearing none, the
- tentative agenda of this meeting tonight calls for
- 17 a Closed Meeting, pursuant to Missouri Revised
- 18 Statute 610.021, One, Legal Actions and Advise;
- 19 Two, Purchase of Real Estate; Three, Personnel
- 20 Matters; Nine, Employee Groups Negotiations;
- 21 Thirteen, Personnel Records and Nineteen,
- 22 Security.
- 23 Do I -- I make a motion to go into
- 24 Closed session.
- 25 DIRECTOR HARRIS: Second.

- 1 DIRECTOR GANS: Discussion?
- 2 (No response.)
- 3 DIRECTOR GANS: All in favor?
- 4 DIRECTOR MILLNER: Aye.
- 5 DIRECTOR HARRIS: Aye.
- 6 DIRECTOR GANS: Aye.
