- 25 I'm sorry, \$260,632.00.

- 1 (Director Millner opening second bid.)
- DIRECTOR GANS: This is why you get
- 3 the big bucks.
- 4 (General chuckles.)
- 5 DIRECTOR MILLNER: Is that one --
- 6 DIRECTOR GANS: I get to sit back
- 7 and run the meeting and you get to do all the
- 8 work.
- 9 DIRECTOR MILLNER: That's alright.
- 10 Okay.
- 11 I'm sorry.
- DIRECTOR GANS: Is the actual
- 13 vehicle in there?
- 14 DIRECTOR MILLNER: No. The bid fell
- 15 apart.
- 16 (Referring to some of the pages coming out
- of the notebook.)
- 18 DIRECTOR MILLNER: Oh, just a
- 19 second.
- If you'll bear with us, just a
- 21 moment, I am putting it back in order, so that I
- 22 can read it.)
- The second bid is from Horton
- 24 Emergency Vehicles.
- 25 The total of this bid, \$262,821.00.

- 1 I'm instructing the chief and his
- 2 committee to review the bids and return a
- 3 recommendation to the Board of Directors.
- 4 CHIEF SPIEGEL: Yes, ma'am.
- 5 DIRECTOR MILLNER: That concludes
- 6 the Secretary's Report.
- 7 DIRECTOR GANS: All right. Thank
- 8 you.
- 9 We move to the Treasurer's Report.
- 10 Since Director Harris is not
- 11 present, I'm going to assume those duties --
- 12 DIRECTOR HARRIS: Thank you.
- DIRECTOR GANS: -- of the
- 14 treasurer.
- 15 I'm good.
- DIRECTOR MILLNER: Okay.
- 17 DIRECTOR GANS: Tonight, we have
- disbursements in the amount of \$315,326.09.
- 19 That's 3-1-5-3-2-6-point-zero-9.
- We have four checks over the amount
- of \$4,000.00 (sic) which are a check to Central
- 22 County 911 for \$216,987.36.
- Check number 42312.
- 24 This is for tax receipt and
- 25 remittance for dispatch services to Central

- 1 County.
- A check to Mediclaims, Inc.,
- 3 \$7,077.99.
- 4 Check 42344.
- 5 This is the fee for collecting
- 6 ambulance billing.
- 7 A check to S-H-I International
- 8 Corp., for \$17,971.73.
- 9 Check number 42363.
- This is includes and is primarily
- 11 licenses for the District's new email system,
- 12 effective in 2019.
- The email system for all of the
- 14 owners of Central County was reverted back to the
- 15 districts, so Central County's no longer
- 16 providing email services.
- 17 And this is the annual fee for 175
- 18 email licenses and other related fees, for a
- 19 server, for exchange server.
- 20 And, finally, a check to Tech
- 21 Electronics for \$5,499.70.
- Check number 42368.
- And this is to install the upgraded
- 24 fire alarm system at House Five.
- 25 And this is the -- Chief, is this

- the completion of the upgrades from 2018?
- 2 (No response.)
- DIRECTOR GANS: Is that correct?
- 4 Capital for 2018?
- 5 CHIEF SPIEGEL: (not audible)
- 6 DIRECTOR GANS: Or, Fire Marshal
- 7 Herin?
- FIRE MARSHAL HERIN: Roger Herin,
- 9 fire marshal.
- 10 That is one of the final payments,
- 11 I believe.
- 12 DIRECTOR GANS: Okay.
- 13 FIRE MARSHAL HERIN: There will be
- 14 three, in total.
- But, the work is done. The work is
- 16 complete and we're waiting on a certificate from
- "U.F." to certify the system before we give the
- 18 final payments.
- 19 So, that's -- that is a project
- 20 payment (two words not clear.)
- 21 DIRECTOR GANS: Okay. Thank you.
- 22 Are there any questions about those,
- or any of the other checks?
- 24 DIRECTOR HARRIS: All of my
- 25 questions were answered via email.

- 1 DIRECTOR GANS: Okay.
- DIRECTOR MILLNER: I have no
- 3 questions.
- 4 DIRECTOR GANS: All right.
- 5 And he's referring to an email that
- 6 I sent earlier today with a copy to the public
- 7 file that had a few questions on it about the
- 8 check run.
- 9 They were satisfactorily answered by
- 10 the chief and the controller.
- And those, as I said, are available
- in the public file.
- In reviewing these disbursements,
- 14 they appear to be reasonable and necessary in the
- 15 conduct of the District's business.
- 16 Chief Spiegel, were these checks
- 17 prepared per your recommendation?
- 18 CHIEF SPIEGEL: Yes, they were.
- 19 DIRECTOR HARRIS: Do they violate
- 20 any state bidding statutes, or constitute
- 21 installment payments?
- 22 CHIEF SPIEGEL: None that I'm aware
- 23 of.
- 24 DIRECTOR HARRIS: I make a motion
- 25 that we accept the disbursements as prepared.
