OPEN MEETING MINUTES

MEETING DATE JULY 20, 2021

A quorum of the Board of Directors being present, the Open Meeting of the Monarch Fire Protection District for July 20, 2021, is called to Order by Director Gans at 4:00 p.m.

It is further announced that the Open Meeting of the Board of Directors is in session for the transaction of Monarch Fire Protection District business.

<u>Present at the Open Meeting</u>: Director Gans, Director Harris, Director Millner, Assistant Chief Crews and legal counsel Matt Hoffman.

Everyone in attendance participates in the Pledge of Allegiance to begin the Open Board Meeting.

After a discussion, there are no changes to the Board Meeting Agenda.

Also, it is reported by the administrative staff that there are no citizen comments or questions submitted by residents of the Monarch Fire Protection District for a response from the Board of Directors.

Under the President's Report, the proposed update to the Capital Asset Policy is discussed in detail with Controller Abby Sowatsky, which will increase the various capitalization thresholds to a minimum of \$5,000.00. (A copy of the relevant schedule is attached).

Motion by Director Gans to approve the updated Capital Asset Policy as recommended by Controller Sowatsky. Second by Director Millner. All in favor.

Under the Treasurer's Report, Director Gans, reporting for Director Harris, states that there are total disbursements for the period in the amount of \$279,638.54.

Additionally, there are three (3) disbursements over the amount of \$5,000.00, which include the following:

Ameren Missouri - \$6,055.55 United Healthcare - \$219,432.20 Unum - \$6,306.77

The disbursements are discussed in detail. Director Gans states that specific questions regarding the disbursements have previously been submitted by the Board of Directors to the District Controller. Additionally, it is announced that a copy of the inquiries were sent electronically to the Public File of the Monarch Fire Protection District.

After discussion, Assistant Chief Crews states that the checks were prepared per his recommendation and, to his knowledge, the payments do not violate any state bidding statutes or constitute installment payments.

Motion by Director Gans to approve the disbursements as prepared. Second by Director Harris All in favor.

The remaining items include subcontractor contracts from Feathershark (\$29,441.01) for audio visual/networking and Tech Electronics (\$27,720.00) for phone/security.

Assistant Chief Crews also states that the project is expected to be under budget.

Motion by Director Gans to approve Change Order #9 for additional electrical work to be performed by Icon Contracting (\$33,240.00), together with related subcontractor work at the training center by Feathershark (\$29,441.01) for audio visual/networking and Tech Electronics (\$27,720.00) for phone/security. Second by Director Millner. All in favor.
